Definitions

- The Company: Black Horse Distillery (Pty) Ltd
- The Receiver: The purchaser and receiver of goods
- The Applicant: An authorized representative of the receiver and signee.

The Applicant

- The Applicant must have the required legal capacity to enter into and be bound by these terms and conditions.
- The Receiver's delivery address will be the place to which any deliveries will be made.
- Should the Receiver's delivery address change the Applicant or authorized representative will inform us of such change in writing and e-mailed to distillery@blackhorse.co.za

Payments and Accounts

- Payments can be made via TT, electronic funds transfer, direct deposit, credit card, PayFast or Zapper.
- Unless otherwise agreed in writing, all accounts are strictly COD and as such delivery can only be made when payment reflects in our accounts.

Deliveries and Acceptance of Goods

- Packed COD orders will only be kept for a period of one week pending payment in the Company's account. Thereafter the order will be cancelled and returned to stock.
- Delivery of goods are offered within the Gauteng Province of South Africa only at no extra charge at the Company's discretion.
- The Receiver will be obliged to take delivery of the products when tendered. A delivery note or document evidencing collection must be signed by an authorized representative.
- In the event of delivery not being accepted by the Receiver a delivery charge will be levied henceforth.
- Deliveries outside of South Africa are to be arranged by the Receiver and for the Receiver's account. EXW
- Any claims (short received, wrong product, damaged goods, etc) must be submitted in writing and submitted to the Company via e-mail to distillery@blackhorse.co.za
